- 1. All Breed: A new hotel had to be booked for the judges and transportation help will be needed to and from the hotel for judges. Still waiting on contract from Fairgrounds. Megan Philpot is researching price quotes for a new Superintendent in 2024.
- 2. Obedience: Applications for the November OB/Rally trials and will ensure the same teams of people are willing to head up the various teams that run the trial. Judges were hired through 2024 but the person who was hired to replace the judge who backed out a few months ago (November 2024 trial) also backed out. Another judge will have to be hired for that trial. 2025 judges will be hired this summer.
- 3. Agility: Trial: Nothing. May RRNDOC coming up and all is well.
- 4. Scent Work: June trial is on track. September location will be finalized in the next couple of weeks.

- 1. How to enforce instructors, when not actively teaching, will pay for floor time- Instructors will be held to the honor system.
- 2. Increasing fees for OB/Rally trial Secretary. Motion made by Sarah Ford / Second by Julie Hulne "OB/Rally secretary shall be paid a fee of \$75 per trial. Fees in excess of the amount will not be paid unless preapproved by the BOD in advance of the trial." **Motion Passed**

- 4. Building Manager Salary Increase Tabled until next meeting.
- 5. How will the payment structure of the Training Director look? Tabled until next meeting.
